IFA provides food to 500 kids in 5 of the poorest schools in Ethiopia. These lunches provide the malnourished kids with their only meal for the day; the kids are from broken families or have lost their parents to AIDS. A School Health and Nutrition (SHN) program can play an instrumental role in meeting the challenge of malnutrition by helping maintain the school structure, and consequently providing education, while contributing to good health. SHN also indirectly contributes in improving the nutritional status of families whose children are enrolled in an SHN program as their familial demand and requirement for food is decreased.

As well as directly addressing hunger, school meal projects encourage families to keep their children in school and so help them build better futures. Reducing hunger in school children contributes to their improved cognition and better concentration. In addition, when an adequate supply of micro-nutrients is combined with deworming, school feeding strengthens the overall health status of children. Thus with a solid education and improved health status, growing children have a better chance of finding their own way out of hunger.

In 2014 IFA launched its "Sustainable School Health and Nutrition Program" (SSHNP) in 2 primary schools in Addis Ababa. During 2015 the program was expanded to include 2 more primary schools in Addis Ababa and a fifth school, a rural primary school, in Northern Shewa. IFA's SSHNP is in line with a number of the new global Sustainable Development Goals adopted at the UN conference in September 2015 and Ethiopia's commitment to the Segota Declaration, "A commitment to end child under-nutrition in Ethiopia by 2030".

The SSHNP program complements the SHN by adding an "Income Generating Activity" (IGA) program to the SHN program. The purpose of these IGA's is to enable the SSHNP program to be self-supporting from inception, by securing the necessary funds to mitigate donor dependence. All profits received from the IGAs are reinvested into the SHN program. The design is collaborative and implemented in close partnership with the School's community, the local community, local small businesses, government bodies, and other stakeholders to bring about sustainable change and resilience. During 2015 IFA completed constructing and equipping two bakeries. These businesses will be launched in 2016 once the appropriate business licenses have been obtained.

In October 2015, IFA started a School Eye Health Program (SEHP) in partnership with Better Sight Better Learning Foundation (based in the Netherlands) and Signum Vitae Eye Care Center, a private eye clinic enterprise in Ethiopia. SEHP works in 10 primary schools in Addis Ababa. Under this program IFA provided 165 pairs of eyeglasses for children with uncorrected refraction errors. Eye infections are common in Ethiopia and IFA gave medical treatment to 71 children to cure these infections.
